## **DEED IN DISTRIBUTION OF TRUST ASSETS**

## WHEREAS,

- (a) by Trust Agreement dated September 16, 2004, between Eva C. Taylor, as Grantor, and Bank of America, N.A., as Trustee, there was established and created the "Eva C. Taylor Revocable Trust" ("Trust Agreement"). Such Trust Agreement was amended by First Amendment thereto dated March 22, 2005;
