MEMORANDUM OF AMENDED AGRÉEMENT CONCERNING SURFACE DISCHARGE OF PRODUCED WATER

KNOW ALL MEN BY THESE PRESENTS:

Bert W. Dow, trustee under the Bert W. Dow Revocable Trust dated March 6, 2003, of 63 Dow Road, Sheridan, WY 82801 (the "Owner"), and J. M. Huber Corporation, a New Jersey corporation, with offices located at 1050 17th Street, Suite 800, Denver, CO 80265 ("Huber"), have entered into that certain Agreement Concerning Surface Discharge of Produced Water dated February 12, 2004 (the "Agreement"). A Memorandum of the Agreement was recorded with the Clerk of Sheridan County on February 27, 2007 at Book 482, Page 0343.

Pursuant to the Agreement Owner and Huber have agreed upon, among other things, the conditions under which Huber may disperse or dispose of on the Lands water produced from Huber's coalbed methane wells. By a Second Amendment to the Agreement dated May 8, 2007, Operator and Owner have amended the Agreement to add Lots 1, 2, 3 and 4 of Section 33, Township 58 North, Range 82 West, 6th P.M., Sheridan County and to address other matters. All of the acreage now subject to the Agreement, as so amended, is described on the attached Exhibit A.

This Memorandum is executed by Owner and Huber and recorded in Sheridan County, Wyoming to serve as notice of the existence of the Agreement, as amended. The parties acknowledge they and their successors and assigns are bound by all the terms and conditions of the Agreement, but only to the extent the Agreement covers the Lands.

A complete copy of the Agreement is maintained at the offices of Huber at the address above. Any person desiring to deal with the Lands may contact Huber for information as to all of the terms of the Agreement.


