The undersigned covenant that they are the owners of the above-described lands and that the said lands are free and clear of encumbrances and liens of whatsoever character except those held by the following persons:

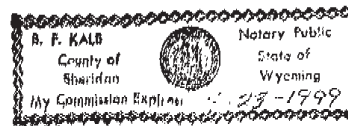

ADDENDUM

Addendum to the Right-of-Way Easement from Jack Dow for a buried telecommunications cable, according to Wyoming State Law.

Commencing at the Southwest corner marker of Section 19, T58N, R82W of the Principal Meridian Wyoming, thence North $1^{\circ}0'$ East for a distance of 2600 feet to the point of beginning of the buried telecommunications cable. Thence South $84^{\circ}0'$ East for a distance of 2600 feet. Thence North $70^{\circ}0'$ East for a distance of 800 feet. Thence North $85^{\circ}0'$ East for a distance of 2000 feet. Thence North $70^{\circ}0'$ East for a distance of 1500 feet. Thence North $20^{\circ}0'$ East for a distance of 300 feet. Cable lays approx. 20 feet outside of road right-of-way and runs parallel to the north side of the Badger Creek road through sections 20, 21, 27, 28, 34, 35.
