## AGREEMENT FOR CONSTRUCTION EASEMENT

THIS AGREEMENT, is by and between <u>Susan C. Hiller</u>, hereinafter referred to as the Property Owner and Sheridan County, Wyoming, hereinafter referred to as the County,

WHEREAS, the County proposes to improve approximately 6,200 meters of County Road No. 104 and County Road No. 67.

AND WHEREAS, the Property Owner is willing to convey to the County the necessary temporary construction easements,

NOW THEREFORE, in consideration of mutual covenants set forth herein and for other good and valuable consideration, the parties agree as follows:

- 1. Property Owner agrees to convey unto the County a new temporary construction easement on property adjacent to River Road in T57N, R85W, 6<sup>th</sup> P.M., Sheridan County, Wyoming, as described on attached Exhibit "A." Temporary construction easement will expire at end of Contractor's one year warranty.
- 2. The County will seed all disturbed areas in the construction easement with a dryland seed mix.
- 3. The County will rebuild a 5 meter approach surfaced with crushed base at station 1+842 LT.
- 4. The County will update the existing approach at station 1+598 LT to 5 meter width and surfaced with crushed base.
- 5. The County will place new Type F barbed wire fence from station 1+510 LT to station 1+950 LT. Specialty pole fence will be replaced with pole fence. Existing fence will be stockpiled on Landowner's property.
- 6. Culvert at station 1+870 to become property of Landowner, if salvageable.

Re: Temporary Construction Easement
