Teresa E. Nowakowski, being first duly sworn according to law, and in accordance with Wyoming Statute § 2-1-201, deposes and states:

1. The undersigned affiant is the designated Executor and Personal Representative of the Estate of Geraldine P. McCallister ("Decedent"), according to a written instrument entitled, "The Last Will and Testament of Geraldine P. McCallister," duly executed in Sheridan County on July 25, 2023, and filed of record, but without probate or administration, in the District Court for Sheridan County, Wyoming, pursuant to Wyo. Stat. § 2-6-121.

2. Geraldine P. McCallister died in Yellowstone County, Montana, on February 17, 2024, according to the Certificate of Death for the State of Montana Department of Health, a certified copy of which is attached hereto and made a part hereof as Exhibit "A."

3. The value of Decedent's estate, located in Wyoming, less liens and encumbrances, does not exceed two hundred thousand dollars (\$200,000).

4. More than thirty (30) days have elapsed since the date of the death of Decedent.

5. No application for appointment of a personal representative is pending or has been granted in any jurisdiction in this state.

6. Article III of Decedent's Last Will and Testament appoints the undersigned as Personal Representative of Decedent's estate, giving her the fiduciary powers which a personal representative may exercise under the laws of the State of Wyoming.

7. In accordance with the foregoing averments and Wyo. Stat. Ann. § 2-1-201, the undersigned affiant is entitled to the distribution of all personal property, the payment of all




accounts, and the transfer of all titles and other documents of ownership belonging to the Decedent
at her death, including, but not limited to, the following:

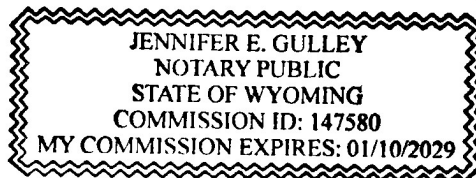

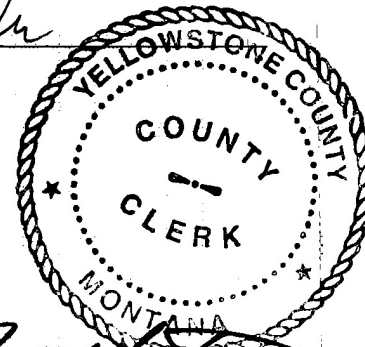
