EXHIBIT "A"

A tract of land situated in the NE1/4NW1/4 of Section 18, Township 53 North, Range 83 West, 6th P.M., Sheridan County, Wyoming, described as follows:

Beginning at a point located on the South right-of-way line of the Wyoming Secondary Highway, said point being East 800 feet and South 40 feet from the Northwest corner of said NE1/4NW1/4 of said Section 18; thence, along the South right-of-way line of said Highway, East a distance of 125 feet to a point (said point being also on the West right-ofway line of and access road running South); thence South along said West right-of-way line of said access road a distance of 136.4 feet, thence S34°45'W along the Westerly right-ofway line of said access road a distance of 219.3 feet more or less, to a point, thence North a distance of 317 feet, more or less, to the point of beginning.
