WARRANTY DEED

Agreement dated February 21, 1991, GRANTOR, for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration in hand paid, receipt and sufficiency of which is hereby acknowledged, conveys and warrants to Heidi E. Gustafson, a single person, GRANTEE, whose address is Po Box 1262 Dobis, 47, the following described real estate, which is a portion of Tract No. 14 of Paradise Park Subdivision, a Subdivision in Sheridan County Wyoming, located in the SW1/4 of Section 9, Township 55 North, Range 85 West, duly filed and recorded in the office of the County Clerk of Sheridan County, Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State of Wyoming, more particularly described as:
