ORDINANCE NO. 275

AN ORDINANCE annexing a partel of land lying in the NE 1/4 NW 1/4 of Section 32, Township 57 North, Range 86 West, of the Sixth Principal Meridian, Sheridan County, Wyoming.

WHEREAS, Bob and Roxanne Braunberger, being the owners of lands in Sheridan County, Wyoming, hereinafter described, has petitioned the Town of Dayton in writing for the annexation of said lands to the Town of Dayton, with a request for a zoning classification of R-1 Residential;
