## AMENDMENT OF DECLARATION OF PROTECTIVE RESTRICTIONS OF DON-ENA ESTATES

COME NOW, the undersigned, all being owners of Lots in the Don-Ena Estates, and being more than seventy-five percent (75%) of the owners of the lots in Don-Ena Estates, and do hereby, under the provisions of paragraph 24 of the Declaration of Protective Restrictions of Don-Ena Estates as originally recorded on May 16, 1975, Book 208, Page 572, Instrument No. 664145 with the County Clerk for Sheridan County, amend and modify said protective restrictions as follows:

Paragraph 24: Amend in its entirety to read as follows:

24. These protective restrictions are to run with the land and shall be binding on all parties and all persons claiming under them for a period of twenty-five years (25) years from the date the original protective restrictions were recorded, May 16, 1975. After which time, said protective restrictions shall automatically be extended for successive periods of ten (10) years. These protective restrictions may be amended from time to time in whole or in part by the approval of seventy-five percent (75%) of the then owners of the lots; for the purposes of calculating the seventy-five percent (75%), multiple owners of an individual lot shall be collectively considered a single owner.
