## EASEMENT

## III

The Cooks desire to grant a right-of-way to the Sells for access to the water well and use of the water well.

THEREFORE, the parties agree as follows:

Bryan Cook and Linda Cook, husband and wife, hereby convey and grant an easement to Laverne Sell and Wanda Sell for purposes of access to a water well located on property owned by Cooks. The easement covers the following described property:

A tract of ground located in and being a portion of Lot 20, Block 3 of the First Addition to the Town of Lodore, Sheridan County, Wyoming; being more particularly described as follows: being a strip of land 10 feet wide lying Westerly of and parallel to a line lying 55 feet East of and parallel to the West Line of said Lot 20, Block 3 of the First Addition to the Town of Lodore said strip of ground to extend from the Northerly property line being located on the Highway Right-of-Way, Southerly for 75 ft. along said property line, said tract is to be used for an easement for the purposes of ingress and egress for maintenance and construction of the water line from a common water well being the two adjacent property owners.
