Grantor further declares that Lot 3B will not be used for the sale of liquor or malt beverages for off-property consumption, provided that the term off-property consumption does not exclude sales of alcohol or malt beverages for consumption on the premises.

This restriction runs with the land described above and shall inure the benefit of Grantee and be binding upon Grantor and Grantee and their successors and assigns.
