FIRST AMENDMENT/MODIFICATION
TO GENERAL DECLARATION OF
COVENANTS AND RESTRICTIONS

This First Amendment/Modification to General Declaration of Covenants and Restrictions, is made this 7TH day of August, 2008 by Woodrock Estate's Phase I Home Owner's Association, herein called "the Association" and is effective August 14, 2009.

This First Amendment/Modification having been approved on July 1, 2008, by the affirmative vote of not less than two-thirds (2/3) of the members of the Association then entitled to vote amends Article V, Section 5(l) as follows:

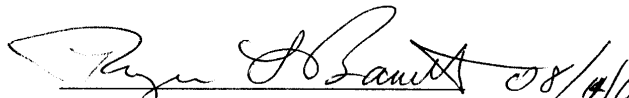
The outdoor storage of snow machines, jet ski machines, ATVs, 5th wheel trailers, camper trailers, boats, RVs, inoperable motor vehicles shall be permitted on in the rear yard of the dwelling lot and shall be within a fenced yard. The fence must be approved by the Architectural Review Committee prior to construction.

This First Amendment/Modification affects real property which is and shall be held, transferred, sold, conveyed and occupied subject to this Amendment and which is located in Dayton, Wyoming and more particularly described as follows:
