ORDINANCE NO 2283

AN ORDINANCE amending Ordinance No. 826, the Zoning Ordinance of the City of Sheridan, to rezone the entirety of the land located at 51 W 4th St., Sheridan, Wyoming more particularly and shown on the attached Exhibit A, from an R-3 Residence District to a B-2 Business District;

WHEREAS, the owner of the following described land has petitioned the City Governing Body to rezone the same from a R-3 Residence District to a B-2 Business District, and a public hearing having been held thereon by the Governing Body; and

WHEREAS, this Ordinance was presented to the City Planning Commission on May 13, 2024 with its recommendation submitted to and received by the City Governing Body; and

WHEREAS, notice of the Governing Body public hearing, as required by W.S. 15-1-602 was published on May 6 2024; and

WHEREAS, the City did not receive a protest against the change of district boundary in accordance with W.S. 15-1-603.

THEREFORE BE IT ORDAINED BY THE CITY OF SHERIDAN GOVERNING BODY:

Section 1.

The following described land is hereby rezoned from an R-3 Residence District to a B-2 Business District, to wit:

Section 2.

The City of Sheridan Zoning Map shall be updated in accordance with this Ordinance.

Section 3

That Ordinance No. 826, The Zoning Ordinance of the City of Sheridan is hereby amended to conform herewith.

Section 4.

If any provision or portion of this ordinance is declared by any court of competent jurisdiction to be void, unconstitutional, or unenforceable, than all remaining provisions and portions of this ordinance shall remain in full force and effect.

Section 5.

That this ordinance shall be in full force and effect immediately upon its passage and publication as provided by law.
