EASEMENT

The Undersigned Grantor(s) for and in consideration of TWO HUNDRED TWENTY-FIVE Dollars Exactly (\$225.00) and other good and valuable consideration, the receipt whereof is hereby acknowledged, do hereby grant and convey to U S WEST COMMUNICATIONS, INC., a Colorado Corporation, (Grantee) whose address is 103 North Durbin Street, Casper, Wyoming 82601, its successors, assigns, lessees, licensees and agents a perpetual easement to construct, reconstruct, operate, maintain and remove such telecommunications facilities as Grantee may require upon, over, under and across the following described land which the Grantor owns or in which the Grantor has any interest, to wit:

An easement ten (10) feet in width by fifteen (15) feet in length, for a remote terminal cabinet site, located in the southeast corner of Lot 1, Subdivision of Block 8 of the Western Addition to the Town, Now City, of Sheridan, Sheridan County, Wyoming, along and abutting the northerly boundary of an Alley, and along and abutting the west side of a concrete sidewalk, westerly of Badger Street, with a site address of 804 West Loucks, all lying in a portion of Section 27, T56N, R84W, of the 6th PM, Sheridan County, Wyoming, said easement site being more particularly described on Exhibit A for right of way number 34467, which is attached hereto and hereby made a part hereof, a part of the property described in a warranty deed in Book 361 at Page 644, in the Clerk and Records Office, in Sheridan County, situate in the County of Sheridan, State of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of this State.

Grantee shall have the right of ingress and egress over and across the Land of the Grantor to and from the above described property and the right to clear and keep cleared all trees and other obstructions. Grantee shall be responsible for all damage caused to Grantor arising from Grantee's exercise of the rights and privileges herein granted.

The Grantor reserves the right to occupy, use and cultivate said Easement for all purposes not inconsistent with, nor interfering with the rights herein granted.

In the case where electric power needs to be brought to the above described easement, the local power company, by this mention, will have the right to co-exist for the sole purpose of providing power to Grantee's facilities.

The rights, conditions and provisions of this easement shall inure to the benefit of and be binding upon the heirs, executors, administrators, successors and assigns of the respective parties hereto.

Any claim, controversy or dispute arising out of this Agreement shall be settled by arbitration in accordance with the applicable rules of the American Arbitration Association, and judgement upon the award rendered by the arbitrator may be entered in any court having jurisdiction thereof. The arbitration shall be conducted in the county where the property is located.
