KEW and ADDIE B. KEW, husband and wife, it being the intention to create an estate by the entireties, grantees, of Sheridan County, and State of Wyoming, the following described real estate, situate in Sheridan County and State of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State, to-wit:
