WATER AGREEMENT

This agreement, made this 5th day of March, 2018 between the Town of Dayton and W. Donald Horn Jr. and Eileen S. Horn owners, located to the south of Eagle Ridge Subdivision, Dayton, Wyoming.

The Town of Dayton agrees to allow Mr. and Mrs. Horn Jr. to connect to the Town of Dayton waterline using a 1- inch main water line. The Horns have received the approval of one water tap for the 35.88-acre parcel (see attached Legal Description) outside the Town limits. Should development occur on the property the owners will be required to pay out-of-town rates for plant investment fees, and a monthly water fee.

It is understood that these water lines will be used for domestic use only. It is understood that watering of livestock or field irrigation is prohibited according to Town Ordinances.

Future owners of the property will pay for a meter and all supplies to hook up the meter when building occurs on the property.

This agreement shall be appurtenant to and run with the land and shall be binding on and to the benefit of the parties hereto, their heirs, successors or assigns in perpetuity.

This agreement is recorded in the Office of the Clerk for Sheridan County, Wyoming.


