- [7] Amendability Or Revocability. Even following the death of the Joint Trustor, Roman Skatula, which occurred on November 4, 2020 - AND, under the authority and express provisions of that certain ROMAN SKATULA AND MARTHA R.SKATULA TRUST MEMORANDUM FOR NOTIFICATION OF AND CONSENT TO AND RATIFICATION OF TRUST MERGER OR COMBINATION UNDER W.S. § 4-10-418, which was made, signed, and acknowledged on February 9, 2021, by the First Interstate Bank, as the sole successor Trustee, acting by and through its duly authorized officers - Linda W. Thompson, Vice President, and by Kim Smith, Assistant Vice President and Trust Specialist III – and was made, signed, and acknowledged on February 10, 2021, by Richard M. Skatula, as Trust Protector acting and signing in the stead of, and for, and on behalf of Martha R. Skatula as the surviving Trustor and sole Qualified Beneficiary - AND, under the provisions of Subsections 1.3, 2.2.3, 2.2.3[a], 2.3.3, and 5.6 of Exhibit A of the Joint Trust Agreement -AND, under the enabling provisions of W.S. § 4-10-710 - AND, with particular regard and reference to the Power Of Appointment and to the Withdrawal Power of the surviving Trustor and sole Qualified Beneficiary, Martha R. Skatula, which remains exercisable through the action of her designated Trust Protector, Richard M. Skatula – the Roman Skatula And Martha R. Skatula Trust thereby continues, in effect, to remain amendable; and, if and to the extent that the Power Of Appointment or the Withdrawal Power of Martha R. Skatula could be exercised as to the whole of the trust estate, in effect, retains its revocability as a Trust entity.

Skatula Trust, or which is held, or hereafter is to be held in trust subject to that Trust entity's Trust Agreement, and as and if amended, restated, or otherwise modified, may be taken in accord with the forms of ownership for which express statutory provision is made in and under W.S. § 4-10-402; and, the ownership by the Trust of non-titled tangible

Skatula Trust. To provide documentary evidence the death of Roman Skatula and for purposes of notification as a matter of public record, the Affiants append to the sworn and signed original of this AFFIDAVIT, mark as EXHIBIT A, and incorporate herein by this express reference a duplicate original of the State of Wyoming Department of Health Certificate of Death for Roman Skatula; which said Certificate of Death is identified by State File Number 2020-004352, which appears in the upper right-hand corner of that appended duplicate original document.
