AFFIDAVIT OF SUCCESSOR TRUSTEESHIP

Pursuant to Wyo. Stat. Ann. § 34-2-123 (2023), the undersigned, being first duly sworn upon an oath, deposes and states as follows:

- 1. Name of Trust. The name of the Trust to which this Affidavit pertains is The Sharon Camis Living Trust, dated September 25, 2006, as amended June 7, 2022 (hereinafter the "Trust").
- 2. Initial Trustee. The initially named Co-Trustees of the Trust, as amended, were Sharon Camis and Cherilyn R. Shiek.
- 3. Successor Trustee. The identity and address of the named, authorized, and currently serving Trustee of the Trust is Cherilyn R. Shiek, presently of 1807 Paintbrush Drive, Sheridan, Wyoming 82801.
- 4. Circumstances of Succession as Successor Trustee. Section Article IV, Subsection A of the Trust, as amended, provides in pertinent part: "Sharon Camis . . . and the Trustor's daughter, Cherilyn Rene Shiek . . . shall serve as Co-Trustees of this Trust. Upon the death, incompetency, resignation, inability or failure to serve of Sharon Camis, then the Trustor's daughter, Cherilyn Rene Shiek . . . shall serve alone as Trustee of this Trust."

On November 21, 2024, a licensed physician who examined or was fully aware and knowledgeable of Sharon Camis' condition, stated and signed a document setting forth that, in the physician's opinion, within a reasonable degree of medical certainty, Sharon Camis is not capable of effectively managing her legal, property, financial, and trust affairs, because she is incapacitated or disabled because of illness, age, or any other cause.

Therefore, pursuant to Section Article IV, Subsection A of the Trust, Cherilyn R. Shiek is named and authorized to serve as the successor Trustee of the Trust and has accepted the successor Trustee appointment and is currently serving and will continue to lawfully serve as the successor Trustee of the Trust pursuant to the terms of the Trust.

5. **Sheridan County, Wyoming Real Property.** Included within the assets of the Trust is the following-described real property and improvements situate in Sheridan County, Wyoming:

Lot 26, Holly Ponds Planned Unit Development, Unit Number Two, a subdivision in Sheridan County, Wyoming, as filed in the Office of the Sheridan County Clerk in Drawer H, Plat Number 37;
