ADDENDUM

Addendum to the Right-of-Way Easement from John and Lee Rompf for a buried telecommunications cable, according to Wyoming State Law.

Commencing at the Northwest corner marker of Section 29, T55N, R82W of the Principal Meridian Wyoming, thence South $80^{\circ}0'$ East for a distance of 4600 feet to the point of beginning of the buried telecommunications cable. Thence South $1^{\circ}0'$ East for a distance of 1516 feet. Thence South $89^{\circ}0'$ East for a distance of 1250 feet.
