Stonemill Construction, LLC, a Wyoming limited liability company, GRANTOR, for and in consideration of the sum of Ten and 00/100 Dollars (\$10.00) and other good and valuable consideration the receipt of which is hereby acknowledged, does hereby grant and convey a drainage easement over and across Tract 1 of Riverstone Park Subdivision, (the "Easement Area") as illustrated on Exhibit "A", attached hereto, and more specifically described as:

A DRAINAGE EASEMENT IN TRACT 1 OF RIVERSTONE PARK SUBDIVISION, LOCATED IN THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER (SE1/4SE1/4) OF SECTION 4, TOWNSHIP 56 NORTH, RANGE 84 WEST, 6TH P.M., SHERIDAN COUNTY, WYOMING. BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF SAID SECTION 4; THENCE N 44°19'33" W, 151.21 FEET TO THE EAST CORNER OF SAID TRACT 1 AND THE WEST RIGHT-OF-WAY LINE OF WYOMING STATE HIGHWAY 338 SAID POINT BEING THE POINT OF BEGINNING; THENCE S 67°38'03" W, 110.00 FEET ALONG THE SOUTHEAST LINE OF SAID TRACT 1 TO THE NORTHWEST CORNER OF TRACT 2 OF SAID RIVERSTONE PARK SUBDIVISION; THENCE N 04°34'47" W, 157.74 FEET; THENCE N 67°38'03" E, 61.82 FEET TO SAID WEST RIGHT-OF-WAY LINE OF WYOMING STATE HIGHWAY 338; THENCE S 22°21'57" E, 150.20 FEET ALONG SAID WEST RIGHT-OF-WAY LINE OF WYOMING STATE HIGHWAY 338 TO THE POINT OF BEGINNING. SUBJECT EASEMENT CONTAINING ±12903 SQUARE FEET (± 0.30 ACRES)

SUBJECT TO PRIOR RECORDED EASEMENTS, EXCEPTIONS, RESERVATIONS, RESTRICTIONS, COVENANTS AND CONVEYANCES.


