CORRECTED CITY OF SHERIDAN ORDINANCE NO. 2298

AN ORDINANCE, AMENDING ORDINANCE NO. 826, THE ZONING ORDINANCE OF THE CITY OF SHERIDAN, TO ZONE THE ENTIRETY OF THE LAND MORE PARTICULARLY DESCRIBED BELOW AND SHOWN ON THE ATTACHED EXHIBIT, FROM R-1 RESIDENCE DISTRICT TO B-1 BUSINESS DISTRICT; FOR PROPERTY LOCATED AT 900 E. 5TH STREET, SHERIDAN, WY.

WHEREAS, The original Ordinance 2298 was recorded at the Sheridan County Clerk and Recorder's office on October 22, 2025, file number 2025-802870; and

WHEREAS, the original Ordinance 2298 failed to include the exhibit associated with the Ordinance.

WHEREAS, the terms and conditions of the original Ordinance 2298, restated below, remain in full force and effect; and

WHEREAS, The owners of the following described lands have petitioned the City Council to rezone the same from R-1 Residence District to B-1 Business District; and

WHEREAS, a public hearing has been held thereon by the City Council.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SHERIDAN, WYOMING:

 The following described land is hereby rezoned from R-1 Residence District to B-1 Business District:

A TRACT OF LAND SITUATED IN THE SE1/4SW1/4 OF SECTION 23 AND THE W1/2NE1/4 & E1/2NW1/4 OF SECTION 26, TOWNSHIP 56 NORTH, RANGE 84 WEST, 6TH PRINCIPAL MERIDIAN, SHERIDAN COUNTY, WYOMING, (SEE RECORD OF SURVEY FILED IN DRAWER "A", PLAT NO. 201 IN THE SHERIDAN COUNTY COURTHOUSE); SAID TRACT BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

SAID TRACT CONTAINS 31.85 ACRES MORE OR LESS.

- 3. If any provision or portion of this ordinance is declared by any court of competent jurisdiction to be void, unconstitutional, or unenforceable, then all remaining provisions and portions of this ordinance shall remain in full force and effect.
- 4. This ordinance shall be in full force and effect immediately upon its passage and publication as provided by law.
