AFFIDAVIT OF SUCCESSION OF TRUSTEE

EVA M. BISHOP, after being duly sworn upon oath, does depose and say:

1. Affiant is one of the Co-Trustees of the Al and Eva Bishop Family Trust Dated February 7, 1997. A Fourth Amended Abstract of said Trust was filed in the office of the Sheridan County Clerk and Recorder on January 31, 2018, in Book 46 of Miscellaneous at page 443.

- 2. Affiant is one of the Co-Trustees of said Trust along with Al Bishop.
- 3. Under the terms of the Trust Agreement of said Trust, which are set forth in paragraph V., Section 1 of the Fourth Amended Abstract of Trust referred to above, Affiant Eva M. Bishop is to become the sole Trustee upon the death, resignation or incompetence of Al Bishop.
- 4. Under the terms of the Trust Agreement of said Trust, which are set forth in paragraph V., Section 2 of the Fourth Amended Abstract of Trust referred to above, Affiant Eva M. Bishop has the authority to determine if Al Bishop has become mentally or physically incapacitated to the extent that he cannot carry out his duties as Trustee. Under paragraph V., Section 4, that determination is to be documented by executing and delivering an affidavit setting forth the fact that she has made that determination.
- 5. Eva M. Bishop has now determined that Al Bishop is incompetent because he has become incapacitated to the extent that he cannot carry out his duties as Trustee.
