Fichtner** (hereinafter referred to in places as the **Affiant**), and said **Affiant** serving and acting herein and hereunder in a fiduciary capacity as the **surviving and continuing initial** Trustee of the **Fred A. Fichtner & Pauline M. Fichtner Trust** under its written **Fred A. Fichtner & Pauline M. Fichtner Trust Agreement**, originally dated **October 29, 1997**, and as thereafter amended, restated, or otherwise modified, with relation back to its inception, **certifies, states, and affirms** as herein-below follows with regard to the established and continuing existence of the **Fred A. Fichtner & Pauline M. Fichtner Trust** (including the **Fichtner By-Pass Trust** thereby encompassed and as declared and stated in the **Trust Agreement**); and, also as to the present circumstances of administration and the current Trusteeship of that said **Trust**, with reference to the following described **AFFECTED PROPERTY**.

[4] The aforesaid Fred A. Fichtner & Pauline M. Fichtner Trust under its written Fred A. Fichtner & Pauline M. Fichtner Trust Agreement, originally dated October 29, 1997, and as thereafter amended, restated, or otherwise modified, with relation back to its inception, was established by Fred A. Fichtner and Pauline M. Fichtner, as husband and wife, acting in the first part as the joint Trustors of the Trust entity that is identified by the Trustors' names; and, that said Trust entity (including the Fichtner Bypass Trust thereby encompassed and as declared and stated in the Trust Agreement) still is in existence.

[5] The name of the Trust entity, and the business mailing address of the Trust entity, and the identity of the currently serving and acting continuing initial Trustee of that Trust are stated below:

[a] Under the Declaration Of Trust and the provisions of Subsection 5.1 of Exhibit A of the Fred A. Fichtner & Pauline M. Fichtner Trust Agreement, originally dated October 29, 1997, and as amended, restated, or otherwise modified, with relation back to its inception, in the event of and upon the incapacity or death of the original joint Trustor and initial Co-Trustee, Fred A. Fichtner, that original joint Trustor's surviving spouse, Pauline M. Fichtner, still serves and acts as the surviving and continuing initial Trustee of and under the Fred A. Fichtner & Pauline M. Fichtner Trust.

[i] Following the death of **original Co-Trustor Fred A. Fichtner**, which occurred on October 30, 2020, through the exercise of her reserved rights and powers, under **Subsection 5.2 of the Exhibit A of the Fred A. Fichtner & Pauline M. Fichtner Trust Agreement**, **Pauline M. Fichtner** – acting in her capacities as an **original Co-Trustor** and the **sole surviving and continuing initial Trustee** of and under the **Fred A. Fichtner & Pauline M. Fichtner Trust Agreement** – selected and designated two of her children, namely **Louis Allen Fichtner** and **Francine Wynn Forrester**, to serve with her as **Successor Co-Trustees**. In and with regard to that written designation, however, **Pauline M. Fichtner** expressly declares and states in the **amended and entirely restated Subsection 5.1 of the Exhibit A of the Fred A. Fichtner & Pauline M. Fichtner Trust Agreement** as follows:

“Without requiring multiple signatures, each Trustee hereby is granted the sole and several power to conduct the business of and to bind the trust entity; and, in furtherance thereof, to sign checks, withdrawal orders, negotiable instrument endorsements, assignments, transfers, deeds and other documents of conveyance, proxies, and all other written instruments and documents, including correspondence and memoranda on behalf of the trust entity; and, to delegate fiduciary powers and responsibilities among themselves as circumstances may require.”

[ii] In the event of the subsequent incapacity or death of **Pauline M. Fichtner**, however, the above-described **Successor Trustees** (or alternate successors from among their siblings) would become entitled to conduct the trusteeship of the above-described **Fred A. Fichtner & Pauline M. Fichtner Trust** without having to designate a successor then to serve and act in the stead of **Pauline M. Fichtner**.

[6] By operation of law, and under the express provisions of the above-described **Fred A. Fichtner & Pauline M. Fichtner Trust Agreement**, the **currently serving and acting surviving and continuing initial Trustee**, **Pauline M. Fichtner**, or either of the above-described **Successor Co-Trustees** have, and severally may exercise without requiring multiple signatures, at each Trustee’s discretion, and outside-of the controlling or supervisory jurisdiction of any Court, all of the **fiduciary powers** which are

conferred upon Trustees generally by the Trustee Powers provisions that are stated in the **Wyoming Uniform Trust Code**, as published in **W.S. §§ 4-10-815 & 4-10-816**, and all other fiduciary powers that expressly are stated in the **Fred A. Fichtner & Pauline M. Fichtner Trust Agreement**, originally dated October 29, 1997, and as amended, restated, or otherwise modified, with relation back to its inception, the provisions of which said statutory and other express powers the **Affiant** incorporates herein by this express reference.

[7] Upon the death of the original Trustor, **Fred A. Fichtner**, which occurred on **October 30, 2020** – in order to procure and to preserve the potential deferral of **Federal Estate Tax** liability for the **Fichtner By-Pass Trust** portion of the trust estate as a **Qualifying Terminable Interest Property (QTIP) Sub-Trust** – the **Fred A. Fichtner & Pauline M. Fichtner Trust** became and now is irrevocable.

[8] The currently surviving and continuing initial Trustee of the **Fred A. Fichtner & Pauline M. Fichtner Trust** is **Pauline M. Fichtner**, who is the **Affiant** herein and hereunder. For information regarding the designation of **Successor Co-Trustees**, refer to the foregoing **Sub-Paragraph [5][a][i]** in this document.

[9] Any **Taxpayer Identification Number [TIN]** that may be assigned to the **Fred A. Fichtner & Pauline M. Fichtner Trust** entity (including the **Fichtner By-Pass Trust** thereby encompassed and as declared and stated in the Trust Agreement) by the **Internal Revenue Service [IRS]**, following and because of the death of original Co-Trustor **Fred A. Fichtner**, may be requested by any party that is entitled to know that information, by contacting the currently surviving and continuing initial Trustee of the **Fred A. Fichtner & Pauline M. Fichtner Trust** – namely, **Pauline M. Fichtner** – at the address which herein-above is stated.

[10] By operation of law, title to real property, titled tangible personal property, and titled intangible personal property that belongs to the aforesaid **Trust**, or is held, or hereafter is to be held in trust subject to the aforesaid **Trust Agreement** for the said **Trust**, as amended, restated, or otherwise modified, may be taken in accord with the forms of ownership for which provision is made in and under **W.S. § 4-10-402**; and, the ownership by the **Trust** of non-titled tangible personal property may be taken by simple

possession of a Trustee, on behalf of the Trust entity, as intended to be held in trust subject to the said **Trust Agreement**.

[11] In compliance with W.S. § 4-10-1014[c], the **Affiant** expressly states that the aforesaid **Fred A. Fichtner & Pauline M. Fichtner Trust** has not been amended, restated, otherwise modified, or revoked in any manner that would cause the foregoing representations that are stated in this **CERTIFICATION OF TRUST UNDER W.S. § 4-10-1014** to be incorrect.



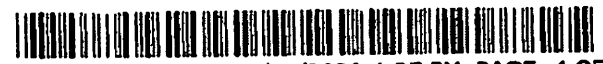

In and with regard to that written designation, however, **Pauline M. Fichtner** expressly declares and states in the **amended and entirely restated Subsection 5.1 of the Exhibit A of the Fred A. Fichtner & Pauline M. Fichtner Trust Agreement** as follows:

“Without requiring multiple signatures, each Trustee hereby is granted the sole and several power to conduct the business of and to bind the trust entity; **and**, in furtherance thereof, to sign checks, withdrawal orders, negotiable instrument endorsements, assignments, transfers, deeds and other documents of conveyance, proxies, and all other written instruments and documents, including correspondence and memoranda on behalf of the trust entity; **and**, to delegate fiduciary powers and responsibilities among themselves as circumstances may require.”

[ii] In the event of the subsequent incapacity or death of **Pauline M. Fichtner**, however, the above-described **Successor Trustees** (or alternate successors from among their siblings) would become entitled to conduct the trusteeship of the above-described **Fred A. Fichtner & Pauline M. Fichtner Trust** without having to designate a successor then to serve and act in the stead of **Pauline M. Fichtner**.

[6] By operation of law, and under the express provisions of the above-described **Fred A. Fichtner & Pauline M. Fichtner Trust Agreement**, the **currently serving and acting surviving and continuing initial Trustee**, **Pauline M. Fichtner**, or either of the above-described **Successor Co-Trustees** have, and severally may exercise without requiring multiple signatures, at each Trustee’s discretion, and outside-of the controlling or supervisory jurisdiction of any Court, all of the **fiduciary powers** which are

conferred upon Trustees generally by the Trustee Powers provisions that are stated in the **Wyoming Uniform Trust Code**, as published in W.S. §§ 4-10-815 & 4-10-816, and all other fiduciary powers that expressly are stated in the **Fred A. Fichtner & Pauline M. Fichtner Trust Agreement**, originally dated October 29, 1997, and as amended, restated, or otherwise modified, with relation back to its inception, the provisions of which said statutory and other express powers the **Affiant** incorporates herein by this express reference.

[7] Upon the death of the original Trustor, **Fred A. Fichtner**, which occurred on **October 30, 2020** – in order to procure and to preserve the potential deferral of **Federal Estate Tax** liability for the **Fichtner By-Pass Trust** portion of the trust estate as a **Qualifying Terminable Interest Property (QTIP) Sub-Trust** – the **Fred A. Fichtner & Pauline M. Fichtner Trust** became and now is irrevocable.

[8] The currently surviving and continuing initial Trustee of the **Fred A. Fichtner & Pauline M. Fichtner Trust** is **Pauline M. Fichtner**, who is the **Affiant** herein and hereunder. For information regarding the designation of **Successor Co-Trustees**, refer to the foregoing **Sub-Paragraph [5][a][i]** in this document.

[9] Any **Taxpayer Identification Number [TIN]** that may be assigned to the **Fred A. Fichtner & Pauline M. Fichtner Trust** entity (including the **Fichtner By-Pass Trust** thereby encompassed and as declared and stated in the Trust Agreement) by the **Internal Revenue Service [IRS]**, following and because of the death of original **Co-Trustor Fred A. Fichtner**, may be requested by any party that is entitled to know that information, by contacting the **currently surviving and continuing initial Trustee** of the **Fred A. Fichtner & Pauline M. Fichtner Trust** – namely, **Pauline M. Fichtner** – at the address which herein-above is stated.

[10] By operation of law, title to real property, titled tangible personal property, and titled intangible personal property that belongs to the aforesaid **Trust**, or is held, or hereafter is to be held in trust subject to the aforesaid **Trust Agreement** for the said **Trust**, as amended, restated, or otherwise modified, may be taken in accord with the forms of ownership for which provision is made in and under W.S. § 4-10-402; and, the ownership by the **Trust** of non-titled tangible personal property may be taken by simple

possession of a Trustee, on behalf of the Trust entity, as intended to be held in trust subject to the said Trust Agreement.

[11] In compliance with W.S. § 4-10-1014[c], the Affiant expressly states that the aforesaid **Fred A. Fichtner & Pauline M. Fichtner Trust** has not been amended, restated, otherwise modified, or revoked in any manner that would cause the foregoing representations that are stated in this **CERTIFICATION OF TRUST UNDER W.S. § 4-10-1014** to be incorrect.


