## PARTITION FENCE AGREEMENT

THIS AGREEMENT, Made and entered into this 11 day of June, 1938, by and between The Wyoming Securities Company, a Wyoming Corporation, acting by and through its duly authorized officers and agents, the Party of the First Part, and Paul Koltiska, in proper person, the Party of the Second Part,

WITNESSETH: That

WHEREAS, it is the desire of the parties hereto definitely to fix the rights and responsibilities of the said parties as regards the maintenance of all partition fences between the holdings of the respective parties within the County of Sheridan, Wyoming, in view of Section 103 of Chapter 42 of the Wyoming Revised Statutes 1931; and

WHEREAS, the partition fences between said parties total in length a mile and a half,

NOW THEREFORE, IT IS HEREBY EXPRESSLY AGREED That the portion of the said fence to be maintained by the Party of the First Part, its successors and assigns, hereafter shall be the following:

Beginning at the Southwest corner of the Southeast Quarter of Section 1, Township 55, North Range 83, West of the Sixth Principal Meridian; running thence East to the Southeast corner of said Section 1; thence South a quarter of a mile to the Southeast corner of the Northeast Quarter of the Northeast Quarter of Section 12, same township and range,

a total distance of three quarters of a mile to be maintained by the Party of the First Part.

That the portion of said fence which shall be hereafter maintained by the said Party of the Second Part, his heirs, representatives and assigns, shall be the following: Beginning at the Southeast corner of the Northeast Quarter of the Northeast Quarter of said Section 12; thence South along the section line to the Southeast corner of said Section 12,
