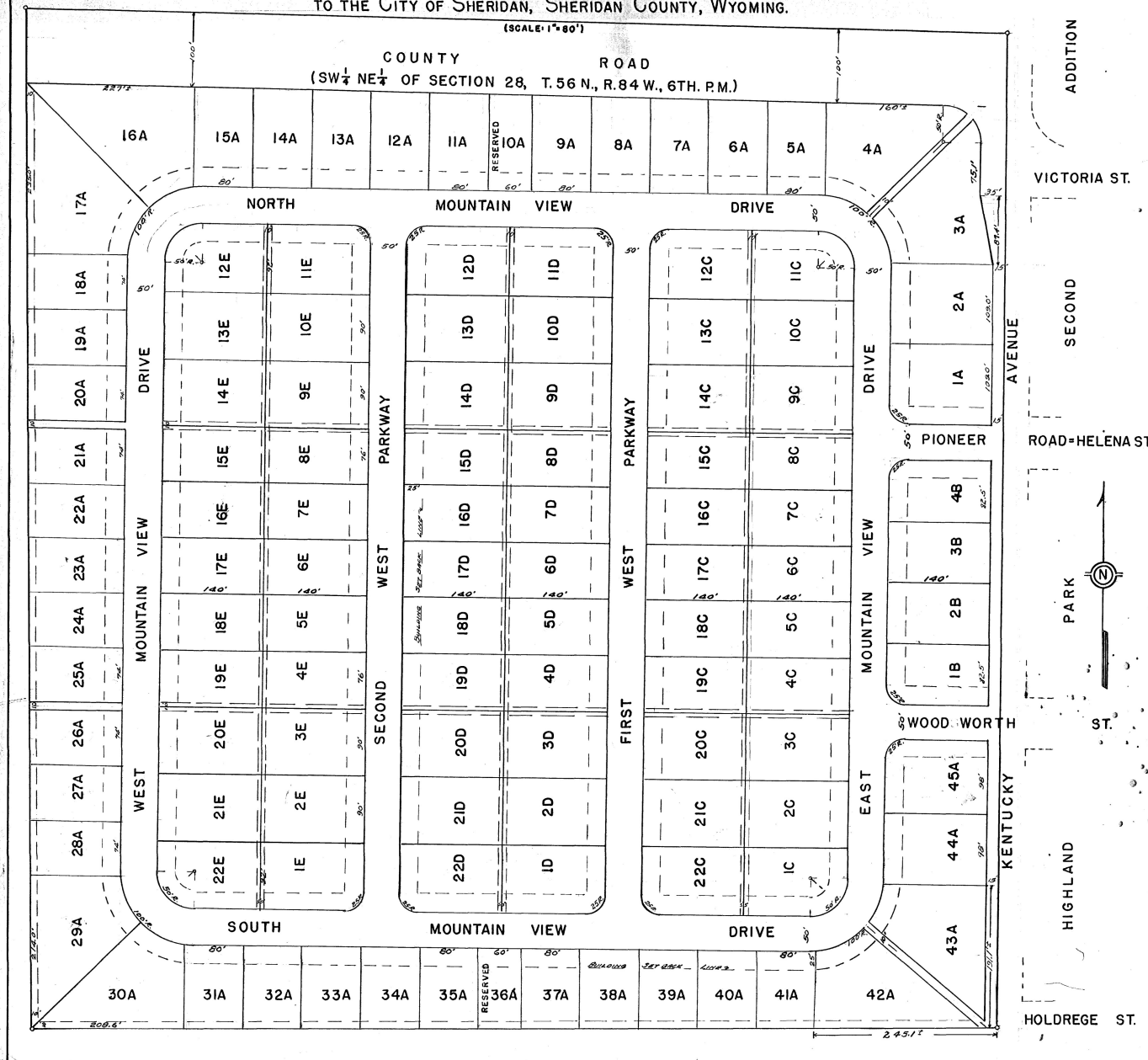

The undersigned, Alice D. Lamb and Tom Lamb, her husband, hereby certify that they are the sole owners and proprietors of the SW 1/4 of Section 28, T.56 N., R.84 W., 6th P.M., County of Sheridan, State of Wyoming, upon which the Country Club Addition to the City of Sheridan, Wyoming, is located and which said SW 1/4 is held out subdivided and platted as a dedicated portion as shown by the Certificate of Survey attached.

That said Addition was laid out and platted with the full knowledge, consent and approval of the undersigned and the Streets, Roads, Drives, Highways, and Alleys indicated on this Plat are hereby dedicated to the use of the public for the usual purposes.
