## WATER WELL AGREEMENT

It is agreed as follows:

- 1. Grantor and Grantee own an undivided one-half interest in the above described well, casing, pump, equipment, and associated water rights and permits and the right to take one-half of the water in the well for domestic purposes on their respective lots.
- assigns, a perpetual easement over and across Lot 2 in Block 1 of Sherri View Subdivision, Sheridan County, Wyoming, for the purpose of maintaining a waterline to convey water from the well to Lot 1 in Block 1 of Sherri View Subdivision.
