T57N, R83W, 6th P.M., Sheridan County, Wyoming SECTION 5: (S/2)SE

Beginning at the SE corner of Section 5, T57N, R83W, Sheridan County, Wyoming, (POINT OF BEGINNING); thence bearing approximately N40°32'W for an approximate distance of 1784', to the point where Powder River Energy Corporation's new three-phase overhead power line enters Pilch Ranch property (TRUE POINT OF BEGINNING).

The new three-phase overhead power line continues from this point bearing approximately S07°16'W for an approximate distance of 1347'; thence bearing approximately S03°01'W for an approximate distance of 63'; where it leaves Pilch Ranch property (POINT OF ENDING), this point being located on an approximate bearing of S86°40'W at an approximate distance of 1298' from the SE corner Section 5, T57N, R83W, Sheridan County, Wyoming.

The above description is for a three-phase 24.9/14.4kV overhead power line "Right-of-Way", 30' in width, being 15' on either side of centerline extending an approximate total distance of 1410 feet.
