SECOND MODIFICATION OF MORTGAGE, SECURITY AGREEMENT, ASSIGNMENT OF LEASES AND RENTS AND FIXTURE FILING

This Second Modification of Mortgage, Security Agreement, Assignment of Leases and Rents and Fixture Filing (this "Modification"), dated as of June 28, 2023, is made by and between R&M COMMERCIAL PROPERTIES, LLC, a Minnesota limited liability company ("Mortgagor"), whose address is 701 Carlson Parkway, Suite 1010, Minnetonka, MN 55305, as mortgagor, and AGWEST FARM CREDIT, FLCA, successor in interest to Northwest Farm Credit Services, FLCA, a corporation organized and existing under the laws of the United States, as Collateral Agent and mortgagee ("Mortgagee") for the benefit of the Lender defined below in the Loan Agreement defined below. Mortgagee's physical address is 2001 South Flint Road, Spokane, WA 99224-9198, and mailing address is P. O. Box 2515, Spokane, WA 99220-2515

- A. Mortgagor is the mortgagor and Mortgagee is the mortgagee under the Mortgage, Security Agreement, Assignment of Leases and Rents and Fixture Filing dated as December 22, 2020, and recorded December 23, 2020, as Document No. 2020-764958 in the official records of Sheridan County, Wyoming, as amended by a First Modification of Mortgage, Security Agreement, Assignment of Leases and Rents and Fixture Filing dated as of November 7, 2022, and recorded on November 9, 2022 as Document No. 2022-782532 in the official records of Sheridan County, Wyoming (as amended, the "Mortgage"), covering the real property described on the attached Exhibit A.
- B. The Mortgage secures, among other things, the payment and performance of indebtedness of certain Notes which were issued pursuant to a Master Loan Agreement dated as of September 27, 2019, among the Mortgagor and Northwest Farm Credit Services, FLCA (in various capacities) and Northwest Farm Credit Services, PCA (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement").

- C. Mortgagee has succeeded to the interest of Northwest Farm Credit Services, FLCA, in the Loan Agreement, and AgWest Farm Credit, PCA has succeeded to the interest of Northwest Farm Credit Services, PCA in the Loan Agreement. Mortgagee and AgWest Farm Credit, PCA are referred to herein collectively as "Lender".
- D. The parties to the Loan Agreement are entering into an Amendment No. 5 to Master Loan Agreement (the "Amendment No. 5") dated as of even date herewith pursuant to which the Lender has agreed to increase the revolving loan commitment available to Mortgagor to be evidenced by that certain Note (Revolving) dated the date hereof made by the Mortgagor payable to the order of Mortgagee, in the face principal amount of Ten Million and No/100 Dollars (\$10,000,000.00) (and as it may be extended, renewed, modified, amended or restated from time to time, the "Revolving Note").
- E. The parties wish to acknowledge that the obligations evidenced by the Revolving Note are among the obligations secured by the Mortgage.
- F. The latest maturity date of the obligations of Mortgagor under the Loan Agreement is being extended to December 1, 2037.

In consideration of the foregoing premises and for other good and valuable consideration, receipt of which is hereby acknowledged, and intending to be bound hereby, Mortgagor and Mortgagee now agree to modify the Mortgage as follows.

ARTICLE 1 AMENDMENTS

- 1.1 Recitals, References and Definitions.
- a. The recitals hereto are incorporated in and made a part of this Modification.
- b. All references in the Mortgage to the "Loan Agreement" are deemed references to the Loan Agreement, as amended by Amendment No. 5.
 - c. All references in the Mortgage to the "Notes" shall be deemed also to include the Revolving Note.
- d. The table of Notes appearing in Section 3.1(a) of the Mortgage is hereby amended and restated as follows:

- e. All references in the Mortgage to the "Mortgage" are deemed to refer to the Mortgage as amended and supplemented by this Modification.
- f. All capitalized terms used but not otherwise defined in this Modification shall have the meaning given such terms in the Mortgage.
- **1.2 Extension of Maturity.** The Mortgage is hereby amended to provide that the Secured Obligations have a maturity date, exclusive of options to renew or extend, of not later than December 1, 2037.

ARTICLE 2 MISCELLANEOUS

- **2.1 Headings.** Article and section headings are included in this Modification for convenience of reference only and shall not be used in construing this Modification.
- **2.2** Severability. Every provision of this Modification is intended to be severable. The illegality, invalidity or unenforceability of any provision of this Modification shall not in any way affect or impair the remaining provisions of this Modification, which provisions shall remain binding and enforceable.
- **2.3** Successors and Assigns. This Modification applies to, inures to the benefit of and binds all parties to this Modification, their heirs, legatees, devisees, administrators, executors, successors and assigns.
- 2.4 Counterparts. This Modification may be executed in any number of counterparts, each of which, when executed, shall be deemed to be an original, and all of which together shall be deemed to be one and the same instrument.
