WARRANTY DEED

Fay as Trustees of The Nathaniel and Kathleen Fay Trust, dated April 29, 2024, whose address is PO Box 457, Story, Wyoming 82842, and their successors in trust, hereinafter referred to as Grantees, the following-described real estate situate in Sheridan County, Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State of Wyoming:

Lot 4 and the Easterly 25' of Lot 3, Block 2, Town of Lodore, Sheridan County, Wyoming;

TOGETHER WITH all improvements, hereditaments, and appurtenances thereunto belonging to or appertaining thereto;

SUBJECT TO all exceptions, reservations, covenants, conditions, restrictions, easements, rights-of-way, and rights of record.

The Grantees hold the above-described property as Trustees of The Nathaniel and Kathleen Fay Trust, dated April 29, 2024. The Settlors of the Trust are Nathaniel Fay, a/k/a Nathaniel Bowditch Fay, and Kathleen D. Fay, a/k/a Kathleen Downs Fay, husband and wife, who have unrestricted power to amend or revoke the terms of the Trust.
