OSUND, OF SHERIDAN, WYOMING, HEREBY CERTIFY THAT THIS PLAT WAS MADE FROM NOTES TAKEN DURING AN ACTUAL SURVEY MADE BY ME FROM JANUARY THROUGH APRIL OF 1958, AND THAT IT CORRECTLY REPRESENTS ALL THE DATA SHOWN THEREON. ALL LOT CORNERS HAVE BEEN MONUMENTED WITH 1" X 48" IRON PIPES, PAINTED YELLOW, AND DRIVEN ABOVE GRADE, YET SOLIDLY INTO THE GROUND, AS CONSTRUCTION PROGRESSES ON EACH LOT.
