## RESOLUTION

WHEREAS, under the provisions and authority of W.S. 24-6-103, the State Highway Commission of Wyoming is authorized to alter access facilities to which access is controlled or limited to and from abutting or adjacent lands; and

WHEREAS, U.S. Highway number 87 has been established from Ranchester to Sheridan under the following project: FI-179(8); and

WHEREAS, right-of-way documents containing a clause designating portions of said project FI-179(8) as an Access Facility Highway under provisions of the Access Facility Act, Chapter 85 of the 1949 Session Laws of Wyoming, said documents being recorded in the office of the exofficio registrar of deeds, Sheridan County, Wyoming; the lands crossed by said project FI-179(8) being described as: Section 18, T.57N., R.84W., Sections 13, 14, 15, 16 and 17, T.57N., R.85W. of the 6th P.M., Wyoming; and

WHEREAS, it is now the desire of the Wyoming State Highway Commission to remove the Access Facility designation from said project FI-179(8);

NOW, THEREFORE BE IT RESOLVED, that the designation as access facility highway as to said project FI-179(8) is hereby removed, and access to

and from said highway shall be granted subject to reasonable and safe requirements and procedures as established by the Superintendent and Chief Engineer, Wyoming Highway Department.
