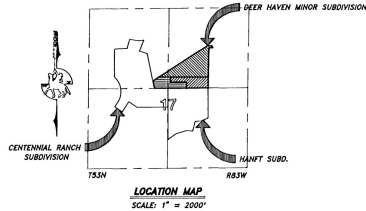


PLAT OF DEER HAVEN MINOR SUBDIVISION

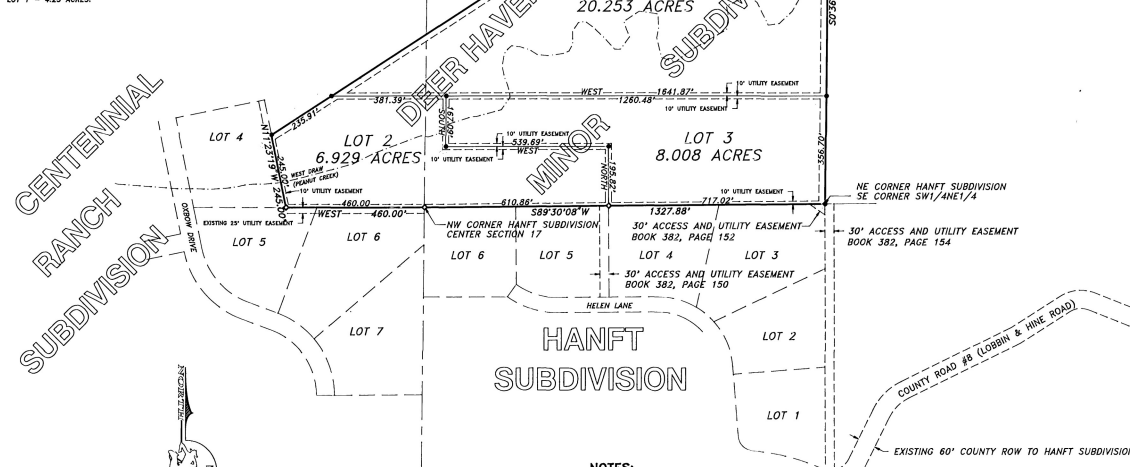

NOTES:

1. NO PROPOSED PUBLIC SEWAGE SYSTEM.
2. NO PROPOSED DOMESTIC WATER SOURCE.
3. NO PUBLIC MAINTENANCE OF STREETS OR ROADS.
4. ANY PURCHASER DOES NOT HAVE THE RIGHT TO THE NATURAL FLOW OF ANY STREAM WITHIN, OR ADJACENT TO THE SUBDIVISION, SINCE WYOMING WATER ADMINISTRATION LAWS DO NOT RECOGNIZE ANY RIPARIAN RIGHTS WITH REGARD TO NATURAL FLOW FOR PERSONS LIVING ON THE BANK OF ANY STREAM OR RIVER.
5. ALL NEW CONSTRUCTION, REMODELING, ADDITIONS OR REPAIRS TO ANY PUBLIC OR PRIVATE BUILDINGS WITHIN THE SUBDIVISION SHALL BE CONSTRUCTED IN ACCORDANCE WITH THE CURRENT BUILDING STANDARDS OF THE NEAREST INCORPORATED CITY OR TOWN OF THE COUNTY THAT HAS ADOPTED BUILDING STANDARDS. BUILDING STANDARDS THAT HAVE BEEN ADOPTED BY THE COUNTY SHALL SUPERSEDE AND GOVERN.
6. THE WELLS AND THE RIGHT TO CONTINUE TO BENEFICIALLY USE WATER UNDER THE TERMS OF PERMIT NUMBER UW96880 WILL BE RETAINED ON LOT 1, DEER HAVEN MINOR SUBDIVISION.

CERTIFICATE OF DEDICATION

THE SUBDIVISION OF A TRACT OF LAND SITUATED IN THE NW1/4NE1/4, NE1/4NE1/4, SW1/4NE1/4, AND THE SE1/4NW1/4, ALL LOCATED IN SECTION 17, TOWNSHIP 53 NORTH, RANGE 83 WEST OF THE 6th P.M., SHERIDAN COUNTY, WYOMING BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF THE NW1/4NE1/4 OF SAID SECTION 17; THENCE ALONG THE EAST LINE OF THE SW1/4NE1/4 OF SAID SECTION 17, 303'35"W, 1325.78 FEET TO THE SOUTHWEST CORNER OF SAID SW1/4NE1/4; THENCE ALONG THE SOUTH LINE OF SAID SW1/4NE1/4, 589'50"00"W, 1327.86 FEET TO THE SOUTHWEST CORNER OF SAID SW1/4NE1/4, SAID POINT ALSO BEING THE SOUTHWEST CORNER OF THE SE1/4NW1/4 OF SAID SECTION 17; THENCE WEST 460.00 FEET; THENCE N11°23'15"W, 245.00 FEET; THENCE N57°07'44"E, 213.15 FEET; THENCE N89°38'00"E, 153.67 FEET TO THE WESTERLY RIGHT OF WAY LINE OF STATE HIGHWAY 193; THENCE ALONG SAID WESTERLY RIGHT OF WAY LINE THROUGH A CURVE TO THE LEFT HAVING A RADIUS OF 320.00 FEET, A CENTRAL ANGLE OF 71°02', AND A CHORD OF 524'48'50"E, 65.91 FEET TO THE INTERSECTION OF SAID WESTERLY RIGHT OF WAY LINE WITH THE SOUTH LINE OF THE NE1/4NE1/4 OF SAID SECTION 17. THENCE LEAVING SAID WESTERLY RIGHT OF WAY LINE ALONG SAID SOUTH LINE OF SAID NE1/4NE1/4, 589'38'00"W, 120.95 FEET TO THE POINT OF BEGINNING.
