IN CONSIDERATION of the payment by the COMPANY of the sum of One (\$1.00) Dollar and other valuable considerations, the OWNER does hereby grant, bargain and convey unto the COMPANY, its successors and assigns, forever, the right, privilege and authority to lay, construct, operate, maintain, repair, and remove, a gas pipe line including necessary pipes, regulators and fixtures, through, over, under and across the following described real estate, in the County of Sheridan, State of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption law of said State, to-wit:



West Half ($W\frac{1}{2}$) of Section Twenty-six (26), Township Fifty-five (55) North of Range Eighty-four (84) West of the Sixth Principal Meridian.

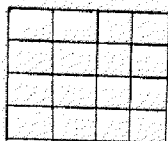

Sheridan County, Wyoming., hereinafter called the "OWNER," WITNESSETH that:

IN CONSIDERATION of the payment by the COMPANY of the sum of One (\$1.00) Dollar and other valuable considerations, the OWNER does hereby grant, bargain and convey unto the COMPANY, its successors and assigns, forever, the right, privilege and authority to lay, construct, operate, maintain, repair, and remove, a gas pipe line including necessary pipes, regulators and fixtures, through, over, under and across the following described real estate, in the County of Sheridan, State of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption law of said State, to-wit:



Southeast quarter (SE $\frac{1}{4}$), South half of Northeast Quarter, (S $\frac{1}{2}$ -NE $\frac{1}{4}$), Northeast quarter of Southwest quarter (NE $\frac{1}{4}$ -SW $\frac{1}{4}$), Southeast quarter of Northwest quarter (SE $\frac{1}{4}$ -NW $\frac{1}{4}$), all in Section Twenty (20), in Township Fifty-four (54) North, Range Eighty-three (83) West of the Sixth

Principal Meridian. The Company agrees that this easement shall

not interfere with the successful operation of farming on said lands; and the Company shall make adjustments in the future necessary to prevent the impairment of farming operations or other enterprises on said lands, except that the Company shall not be un-
