THIS MATTER having come before the Court this date, and the Court having considered the record and being fully advised in the premises finds as follows:

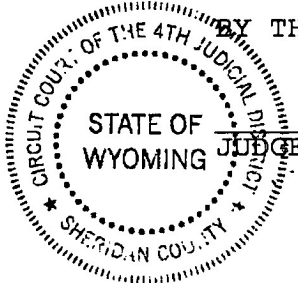
1. The defendant JUSTIN D VREDENBURG was(were) personally served with a copy of the Summons and Complaint;
2. The defendant JUSTIN D VREDENBURG has(have) failed to answer or otherwise plead in the above entitled cause;
3. The court has jurisdiction of the subject matter and parties to this action;
4. There is no just reason for delaying the entry of judgment;
5. Plaintiff should recover judgment against the defendant for JUSTIN D VREDENBURG relief demanded in the Complaint;
6. Collection of insufficient funds check(s) involves recovery of a fine, forfeiture or penalty imposed by a statute for a cause of action which arose in SHERIDAN County, Wyoming, and allowed defendant(s) to obtain money, property or services through the false representation of ability to pay; and

4. \$30.00 for collection fees on dishonored checks as designated  
by W.S. 1-1-115(a);
5. \$100.00 for the costs of this action including filing fees and  
service fees;
6. Post-judgment interest of 10% per annum on the unpaid balance  
of this judgment which now totals \$2393.80.
