- (1) Secured Debts and Future Advances. The term "Secured Debts" includes and this Security Instrument will secure each of the following:
  - (a) Specific Debts. The following debts and all extensions, renewals, refinancings, modifications and replacements. A promissory note or other agreement, No. 82487333, dated April 30, 2014, from Mortgagor to Lender, with a modified loan amount of \$580,224.23 and maturing on May 31, 2017. A promissory note or other agreement, No. 35587663, dated October 2, 2015, from Kolts Fine Spirits LLLP (Borrower) to Lender, with a loan amount of \$195,022.10 and maturing on May 31, 2017.
