- (1) Secured Debts. The term "Secured Debts" includes and this Security Instrument will secure each of the following:
 - (a) Specific Debts. The following debts and all extensions, renewals, refinancings, modifications and replacements. A promissory note or other agreement, No. 35587663, dated October 2, 2015, from Mortgagor to Lender, with a modified loan amount of \$44,034.91 and maturing on June 30, 2027. A promissory note or other agreement, No. 82487333, dated April 30, 2014, from Kolts Fine Spirits LLLP (Borrower) to Lender, with a loan amount of \$578,617.93 and maturing on May 31, 2027.
 - (b) All Debts.
