DRIVEWAY ACCESS EASEMENT

Steven Charles Yates, Personal Representative of the Estate of Bruce Raymond Yates, Case No. 2022-PR-0000120, District Court, Fourth Judicial District, Sheridan County, Wyoming, GRANTOR, for and in consideration of the sum of Ten and 00/100 Dollars (\$10.00) and other good and valuable consideration the receipt of which is hereby acknowledged, does hereby grant an access driveway easement in favor of Steven C. Yates and Carolyn A. Yates, husband and wife, GRANTEES, and their successors in interest in the ownership of the Dominant Parcel (described below), which said easement is granted over and across the route described as follows (the "Easement Route"):

A driveway access easement being a parcel of land situated in Lot 3 of Henry Croghan's Addition to the town of Dayton, Wyoming, Sheridan County, Wyoming as shown on EXHIBIT "B" attached hereto and by this reference made a part hereof; said parcel more particularly described as follows:

BEGINNING at the southwest corner of said Lot 3 (monumented with a 2" aluminum cap per PE&LS 3864); thence N00°28'18"W, 17.94 feet along the west line of said Lot 3 to a point; thence S86°56'24"E, 41.12 feet to a point; thence S60°22'30"E, 25.55 feet to a point; thence S80°51'20"E 22.20 feet to a point lying on the south line of said Lot 3; thence N89°43'27"W, 85.04 feet along said south line to the POINT OF BEGINNING.

Containing 947 sq. ft of land more or less.

Bearings are based on the Wyoming Coordinate System NAD 1983, East Central Zone.

Distances are multiplied to surface by the Datum Adjustment Factor of 1.00025.

<u>Grant of Easement:</u> Grantor grants this driveway easement over and across the Easement Route in favor of and to the benefit Grantees, as the owners of Lot 4, Block 1, Henry Croghan's Addition to the Town of Dayton, County of Sheridan, Wyoming (the "Dominant Parcel").

<u>Intent and Purpose of Easement</u>. Grantors' intent and purpose by this Easement is to provide appurtenant right to access the Dominant Parcel and to provide a non-exclusive right of ingress and egress over and across the Easement Route. Grantor reserves all other rights not otherwise granted herein in the Easement Route.

Neither Grantor, nor Grantee, nor their successors in interest, to the properties subject to this easement, shall bear any responsibility or liability to any person or entity using the Easement Route by reason of this easement. The Grantee will maintain the easement route, and this easement shall run with the land.
