## **DECLARATION OF PARTIAL VACATION OF PLATTED LOTS**

**DECLARANTS** are **FIRST INTERSTATE BANK**, a Montana corporation ("First Interstate Bank") whose address is P.O. Box 2007, Sheridan, Wyoming 82801; **SYSTEM LAND, LLC**, a Wyoming limited liability company ("System Land") whose address is 20 Pine Lane, Sheridan, Wyoming 82801; and **HIDDEN BRIDGE GOLF CLUB, LLC**, a Wyoming limited liability company ("Hidden Bridge Golf Club"), whose address is 550 Mydland Road, Sheridan, Wyoming 82801.

Declarants (also sometimes referred to herein as "Owners") are owners of, and make this Declaration with respect to, the following described real property:

- Lot 1. Tract 1, Sheridan Country Club Minor Subdivision, a subdivision in the City of Sheridan, Sheridan County, Wyoming, filed in Drawer S, Plat 133, in the office of the Sheridan County Clerk.
- Lot 2. Tract 2, Sheridan Country Club Minor Subdivision, a subdivision in the City of Sheridan, Sheridan County, Wyoming, filed in Drawer S, Plat 133, in the office of the Sheridan County Clerk.

The above-described parcels are referred to collectively herein as the "Lots".

WHEREAS, Owners desire to vacate said Lots in Sheridan Country Club Minor Subdivision, a subdivision filed in Drawer S, Plat 133, in the office of the Sheridan County Clerk.

WHEREAS, Owners further desire to re-subdivide and plat said Lots into three (3) new lots which shall be Hidden Bridge Minor Subdivision, a subdivision in the City of Sheridan, Sheridan County, Wyoming, to be filed in the office of the Sheridan County Clerk;

WHEREAS, there are no other lots, tracts or parcels that have access to a public highway through said Lots, whether by easement for right-of-way, publicly dedicated street, or otherwise which would be adversely affected by the vacation and re-subdivision of said Lots;

WHEREAS, any easements for existing utilities and public roads that may be within the boundaries of said Lots, if any, are reserved for continued use to the extent necessary and not otherwise affected by this partial vacation and replat of said Lots.

WHEREFORE, the undersigned, being the record owners of the described Lots, in compliance with Wyo. Stat. Ann. §§ 34-12-106 though 34-12-111 (LexisNexis 2011), do hereby STATE and DECLARE:

1. That part of the plat of Sheridan Country Club Minor Subdivision, only with respect to the foregoing described Lots and as to the legal descriptions thereof, is hereby vacated.
