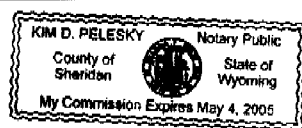

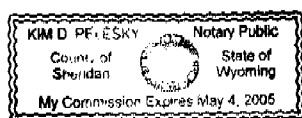

#### ADDENDUM

Addendum to the Rights-of-Way Easement from Steve Schutte for a buried telecommunications cable, according to Wyoming State Law.

Commencing at the Northeast corner marker of Section 21, T54N, R82W of the Principal Meridian Wyoming, thence South 51°0' West for a distance of 3700 feet to the point of beginning of the buried telecommunications cable.

Thence South 65°0' East for a distance of 190 feet.

Thence North 86°0' East for a distance of 600 feet to the Steve Schutte residence..
