#### MEMORANDUM OF RIGHT OF FIRST REFUSAL

THIS MEMORANDUM OF RIGHT OF FIRST REFUSAL ("Memorandum") is made and entered into as of the date JUNE 23, 2025, by and between WILD ROSE PROPERTIES, LLC, a Wyoming limited liability company ("Owner") and CJM LIMITED LIABILITY LIMITED PARTNERSHIP, an Idaho limited partnership ("Grantee") (collectively referred to as the "Parties").

#### RECITALS

- A. Owner is the fee simple owner of certain real property located in 130 Wyoming Avenue, Sheridan, WY 82801 with Parcel No. 56842746500725, more particularly described in Exhibit A, attached hereto and incorporated herein by reference (the "Property").
- B. Pursuant to the Parties Purchase and Sale Agreement dated May 28, 2025 ("Agreement"), Owner has granted Grantee a right of first refusal with respect to any proposed sale, transfer or conveyance of the Property, subject to the terms and conditions of the Agreement ("Right of First Refusal").
- C. The Parties desire to record this Memorandum to give notice of the existence of the Right of First Refusal in favor of Grantee.

NOW THEREFORE, the Parties hereby agree as follows:

1. **Right of First Refusal.** Owner has granted to Grantee a Right of First Refusal with respect to the Property, as more fully set forth in the Agreement. In the event Owner receives a bona fide offer to purchase the Property, or any portion thereof, which Owner intends to accept, Owner must provide written notice of such offer to Grantee. Grantee shall have the right to purchase the Property pursuant to the terms of the Agreement.
2. **Notice.** Any person or entity acquiring an interest in the Property is hereby put on notice of the existence of the Right of First Refusal granted to Grantee under the Agreement and this Memorandum is recorded for such notice.
3. **Term.** The Term of the Agreement shall run with the Property until either: i) Grantee exercises its Right of First Refusal, or ii) Grantee gives its notice to Owner of its intent to waive its Right of First Refusal or Grantee fails to notify Owner of its election to exercise its Right of First Refusal

within a thirty (30) day period after receipt of an Offer Notice and a third-party purchases the Property.

4. **No Modification.** This Memorandum is intended only to provide notice of the existence of the Right of First Refusal in the Agreement and shall not be deemed or construed to modify, amend or supersede any of the terms of the Agreement.
5. **Counterparts.** This Memorandum may be executed in counterparts, each of which shall be deemed an original, but all of which shall constitute one and the same instrument.


