of Sheridan State of Wyoming
hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of this State:

As more particularly described on the accompanying Exhibit for Right-of-Way No. 19160 annexed, a strip of land sixteen feet in width being eight feet on each side of a 'B' line being the Northerly sixteen feet of Lot 27 in the Pierce Subdivision as platted and recorded in the Sheridan County Courthouse at Sheridan, Wyoming.

TOGETHER with the right of ingress and egress over and across the lands of the Grantor to and from the above described property, the right to clear and keep cleared all trees and other obstructions as may be necessary.

The Grantor reserves the right to occupy, use, and cultivate said property for all purposes not inconsistent with the rights herein granted.

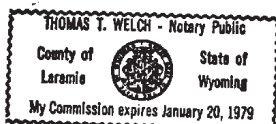

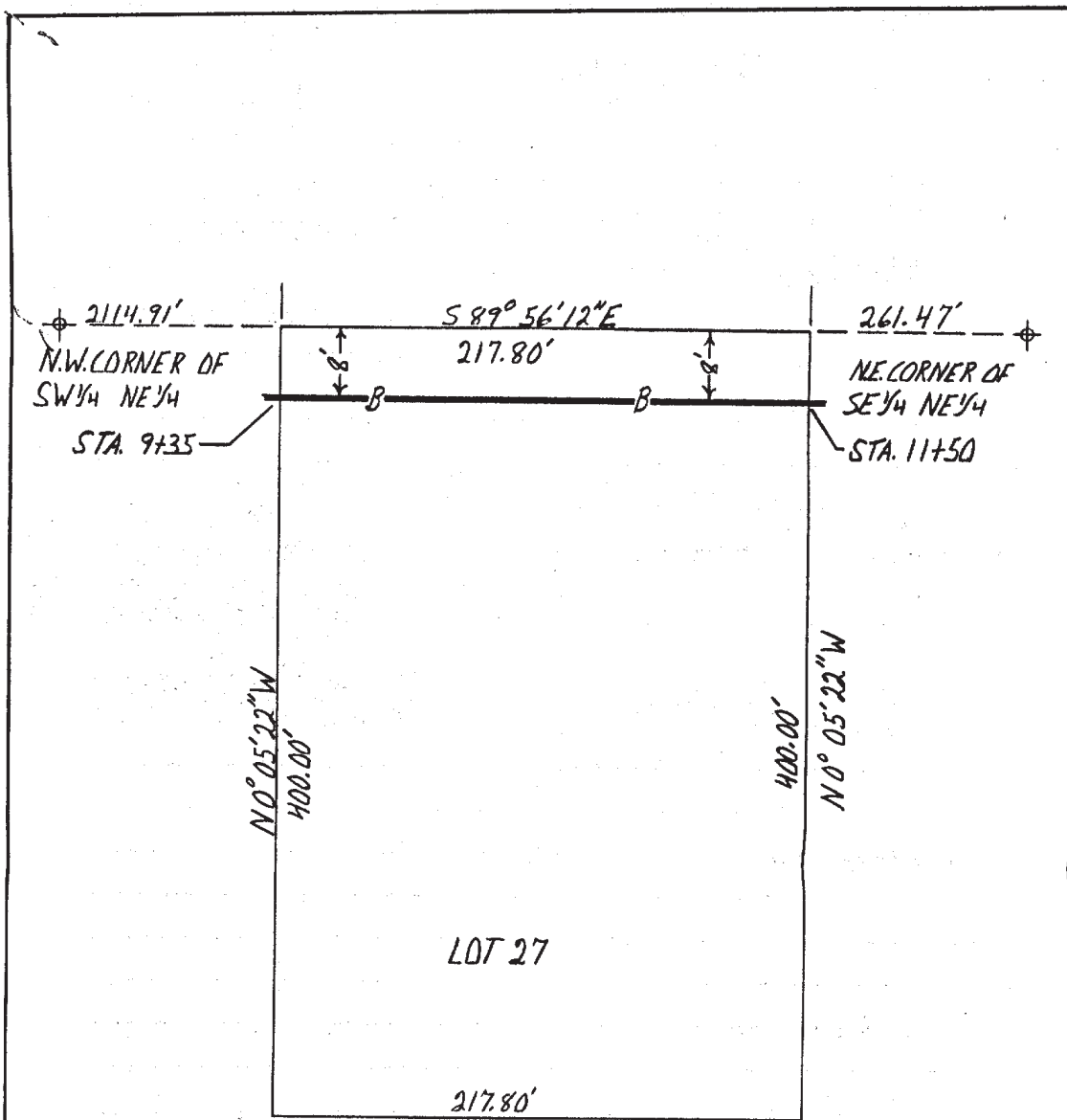

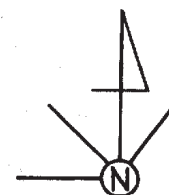
