

CERTIFICATE OF PARTIAL VACATION OF PLAT


COMES NOW, S. Scott Davis and Mary B. Ludemann, husband and wife, the record owners and proprietors of the following described real property to-wit:


Township 56 North, Range 84 West, 6th P.M., Sheridan County, Wyoming

This partial vacation of the above-described plat is made with the free consent and in accordance with the desires of the undersigned owner and proprietor of the lands set forth above.

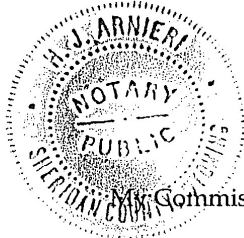
