DEFAULT JUDGMENT

This matter comes before the Court on the Plaintiff's Motion for Default Judgment. Based on that Motion, the Complaint, Return of Service(s) and Affidavit(s)/Unsworn Declaration(s), the Court makes the following findings and conclusion:

1. Defendant(s) Vulcan Coatings LLC and Luke Gattis were served with the Summons and Complaint on 04/23/2024 and default has been duly entered against Defendant(s) for failing to answer or respond.
2. Venue has been considered and is proper.
3. Defendant(s) are not an infant, an incompetent person, an officer or agency of the State of Wyoming or in the military service.
4. Defendant(s) are indebted to Plaintiff for principal of \$294300.00 and accrued interest of \$7844.44.
5. Plaintiff is also entitled to recover court costs of \$270.00.
6. The Plaintiff has complied with 50 U.S.C. App 501-592 commonly known as the Soldiers' and Sailor's Civil Relief Act of 1940.
