

WARRANTY DEED

That for and in consideration of the sum of Ten Dollars (\$10.00) and other valuable considerations, the receipt of which is hereby acknowledged and confessed, CITCO Federal Credit Union, hereinafter called the grantor, hereby conveys and warrants to the TRANSPORTATION COMMISSION OF WYOMING, 5300 Bishop Blvd., Cheyenne, WY 82009-3340, its assigns or successors herein called the grantee, the following described lands located in the County of Sheridan and State of Wyoming, to-wit:

Parcel No. 1A

That portion of Lot 11, Block 49, Sheridan Land Company's Addition to the City of Sheridan, in the NE¼NE¼ of Section 27, T. 56 N., R. 84 W. of the 6th P.M., Wyoming, described by metes and bounds as follows:

Beginning at the point of intersection of the presently existing westerly right-of-way boundary of Main Street with the presently existing northerly right-of-way boundary of West 1st Street, said point also being the southeast corner of said Lot 11, said point also being monumented by a 2 inch aluminum cap per PLS 6812, from which the southwest corner of said Block 49 bears N. 89°34'46.4" W. a distance of 299.95 feet, said point being monumented by a 2 inch aluminum cap per PLS 6812;

thence N. 89°30'41.4" W. along said presently existing northerly right-of-way boundary of West 1st Street a distance of 12.17 feet;

thence leaving said presently existing northerly right-of-way boundary of West 1st Street

N. 69°53'49.8" E. a distance of 7.20 feet;

thence N. 21°09'20.3" E. a distance of 15.34 feet to a point on said presently existing westerly right-of-way boundary of Main Street;

thence S. 00°24'37.9" W. along said presently existing westerly right-of-way boundary of Main Street a distance of 16.89 feet to the point of beginning.

The above described parcel of land contains 61 square feet, more or less.

The basis of bearing for the above described parcel of land is N. 89°34'46.4" W. along the southerly boundary of said Block 49, Sheridan Land Company's Addition to the City of Sheridan.

Excepting and reserving from the above described lands and unto the grantor herein all oil, gas, minerals, and mineral estate of every kind and nature that can be removed from the ground without jeopardy to the maintenance or safety of public use or travel upon the surface estate hereby granted and without using the surface of the lands hereby granted.

Grantor hereby covenants with the grantee, that the grantor is lawfully seized of said lands; that said lands are free from encumbrances, and the grantor hereby warrants the title thereto against the lawful claims of all persons whomsoever.

Grantor releases and waives any and all rights under and by virtue of the Homestead Exemption Laws of this State.

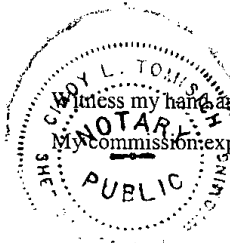
