CERTIFICATE OF PARTIAL VACATION OF PLATTED LANDS

The undersigned acknowledge that easements for existing utilities and State and County roads that may be within the boundaries of the vacated lands are reserved for continued use.

Owner, by these presents, does make the above partial vacation for them and for their successors and assigns, and for all future owners of said Parcel, as shall be re-platted as Stoneridge Meadows Subdivision, Phase I.
