

#### PARTIAL PRIVATE EASEMENT VACATION

This document serves as the official notice and declaration of the partial vacation of a private easement located at the rear of Lots 42 through 57 of The Villages Phase II Major Subdivision (the "Subdivision"), as more particularly described herein. This partial vacation is made pursuant to applicable laws and regulations and is supported by the attached Exhibit "A".

## **RECITALS**

WHEREAS, the easement to be partially vacated is a private easement located at the rear of Lots 42 through 57 of The Villages Phase II Major Subdivision, recorded under Plat V-23, Rec. #2024-793265 in Sheridan County, Wyoming;

WHEREAS, the portion of the private easement subject to this partial vacation is a 15-foot deep area running along the rear of the aforementioned lots, as specifically depicted in the attached survey exhibit (Exhibit A); and

WHEREAS, all parties with an interest in the subject easement have been notified and have consented to this partial vacation, as evidenced by their signatures below.

NOW, THEREFORE, the undersigned declarant(s), on behalf of all owners of Lots 42 through 57 of The Villages Phase 2 Subdivision, hereby vacate the specified portion of the private easement as described herein, subject to the terms and conditions set forth below:

### DESCRIPTION OF VACATED EASEMENT

The vacated portion of the private easement is described as follows:

• A 15-foot wide strip located at the rear of Lots 42 through 57 of The Villages Phase 2 Major Subdivision, as shown on the survey exhibit (Exhibit A) attached hereto and incorporated herein by reference. The remaining portion of the easement not vacated shall remain in full force and effect.

# **EFFECTIVE DATE**

This partial easement vacation shall be effective upon recording of this document and the accompanying survey exhibit in the official records of Sheridan County, Wyoming.
