DECREE OF DISTRIBUTION

This matter came on before the Court pursuant to the filing of an Application for Decree of Distribution ("Application") by Tamala Lynn Larsen, Applicant, and the Court having reviewed the Application, the Notice of Application for Decree of Distribution, and the Affidavit of Publication filed herein, and having been fully advised in the premises, finds as follows:

1. That the Application for Decree of Distribution is properly filed in accordance with W.S. § 2-1-205 through 209.
2. That notice of the Application for Decree of Distribution was published once a week for two consecutive weeks in the Sheridan Press, a newspaper of general circulation in Sheridan County, Wyoming, with the date of first publication being November 25, 2019.
3. That no objections to the Application for Decree of Distribution have been filed with the Court in the thirty (30) days since the date of first publication, and it appears that the facts stated in the petition are not in dispute.
4. That no application for appointment of a personal representative is pending or has been granted in any jurisdiction in Wyoming.

6. At the time of his death, the decedent was the sole owner of the following-described real property located in Sheridan County, Wyoming:


