

ORDER APPROVING FINAL REPORT, ACCOUNTING AND DECREE OF DISTRIBUTION

THIS MATTER came before the Court upon the Final Report, Accounting and Petition for Distribution filed herein by Susan K. Barrett, Personal Representative of the estate. The attorneys for the estate, Davis & Cannon, LLP of Sheridan, Wyoming, have rendered all services required in an estate of this kind and size, and hereby are allowed statutory attorney's fees for ordinary services in the amount of Four Thousand Four Dollars and Ninety One Cents (\$4,004.91), together with out-of-pocket expenses paid by the attorneys for publication and other costs in connection with the administration of the estate, said costs now being Six Hundred Twenty Five Dollars (\$625.00), plus any accruing costs.
