ORDER

On this 10th day of December, 1992, the above matter comes on for hearing before the Court, on the Petition of Hildreth B. Grimes, seeking to have probate proceedings conducted in the District Court of the Eighth Judicial District of the State of Montana, in and for the County of Cascade, in the estate of the above named decedent admitted in this Court as a probate of said estate by this Court, and the Court having reviewed the file of record herein and being duly advised in the premises, finds as follows:

I.

That the certified copies of the proceedings had in the District Court of the Eighth Judicial District of the State of Montana, in and for the County of Cascade as filed with the aforesaid Petition, are sufficient and in accordance with the requirements of W. S. 2-11-201.

II.

That the aforesaid decedent died seized of certain assets located in the County of Sheridan, State of Wyoming, to-wit:

An undivided one-half (1/2) interest in the following described real estate, to-wit:

Lots 11 and 12 in Block 6, Kilbourne Addition to the Town, now City of Sheridan, Sheridan County, Wyoming, together with improvements situate thereon and

Subject to an estate for the life of Alma Y. Grimes.

III.

That said assets were not in excess of a value of \$70,000.00 at the date of death of the decedent.

IV.

That due and proper notice of these proceedings has been given, in accordance with W.S. 2-11-201 and proof thereof by Affidavit of Publication is on file of record herein.

V.

That no objections, written or oral, have been presented to the Court by any creditor of the decedent, or by any other party whomsoever, to the admission of the aforesaid probate proceedings to record in this Court.

Based upon the aforesaid, the Court makes the following:

CONCLUSIONS OF LAW

(1) That the Court has full and complete jurisdiction over the subject matter and all interested parties in this cause.

(2) That the file of record herein is complete and meets all the requirements of W. S. 2-11-201 for the relief prayed for in the petition.

(3) That the Petitioner is entitled to relief as prayed for in the Petition heretofore filed herein.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the certified copies of the proceedings in the estate of the above-named decedent had and conducted in the District Court of the Eighth Judicial District of the State of Montana, in and for the County of Cascade, as filed with Petitioner's Petition herein, be and the same hereby are admitted to record in this Court.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that said certified copies shall, from this day forward, be considered and treated as original proceedings in this Court and shall be conclusive evidence of the facts therein shown, and that all of the estate of said decedent, whether described herein or not, is set over to the surviving spouse of said decedent, Hildreth B. Grimes; that included in said property is the following:

An undivided one-half (1/2) interest in the following described real estate, to-wit:

Lots 11 and 12 in Block 6, Kilbourne Addition  
to the Town, now City of Sheridan, Sheridan  
County, Wyoming, together with improvements  
situate thereon and

Subject to an estate for the life of Alma Y.  
Grimes.
