RESOLUTION FOR THE VACATION OF A PORTION OF
EAST RIDGE ROAD NO. 139

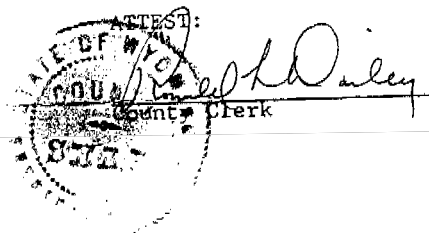
WHEREAS, a petition and plat were filed with the Board of County Commissioners requesting vacation of a portion of East Ridge Road No. 139 located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ and in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 6, Township 55 North, Range 83 West in Sheridan County, Wyoming; and

WHEREAS, said proposed vacation was advertised according to law; and

WHEREAS, no protests were received by 12:00 noon on the 5th day of October, 1992, the deadline for filing objections or claims for damages.

NOW, THEREFORE, a motion was regularly made and carried to vacate said portion of East Ridge Road No. 139, and the same is hereby declared vacated, as hereinabove described and as shown on Exhibit "A", subject to all easements of record and a thirty foot (30') easement to the Montana-Dakota Utilities Company and a thirty foot (30') easement to U S West Communications.

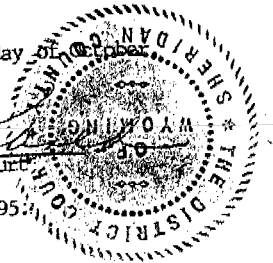

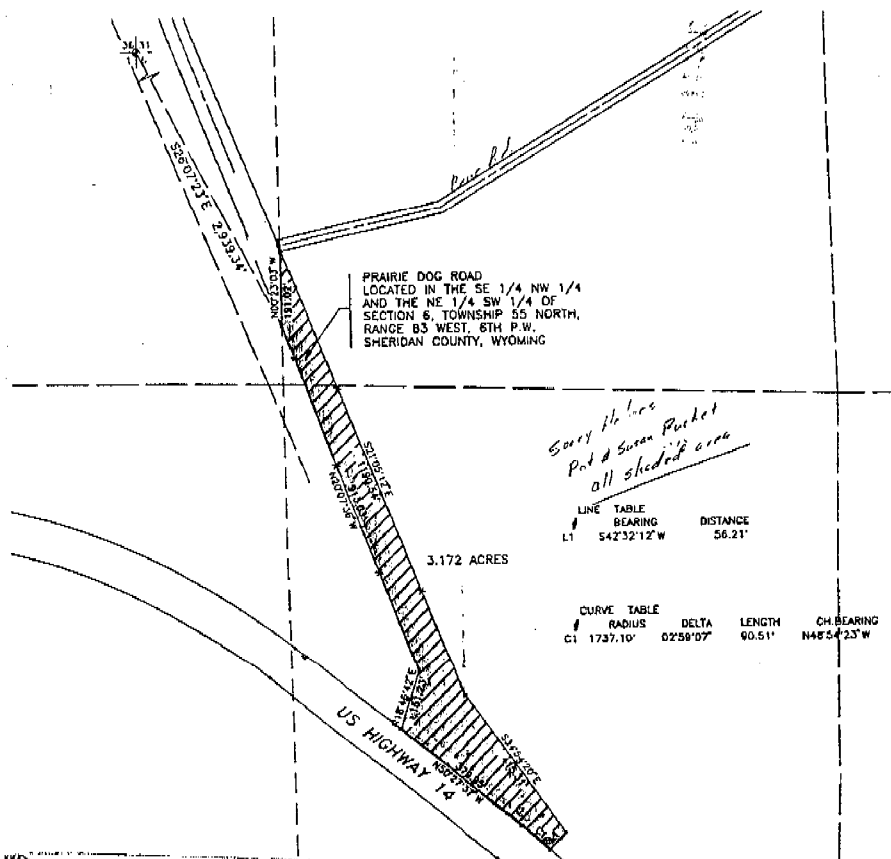
